**ENTRY REGULATIONS**

- All works must be **securely framed**. Frames with **screw eyes and hanging wire** are required for the hanging system in the Gallery. Works deemed unsafe will be returned to the artist. (Clip style frames are not acceptable.)
- Original two-dimensional works (painting, collage, photography, printmaking, stained glass, fiber, drawing, etc.) not previously entered in this exhibit will be accepted.
- Off-white or white mattes are preferred to ensure a coordinated appearance.
- Please be sure to **affix a label on the back of each work** that includes your name, phone number, title of the work, price and medium.
- Sales are not conducted by the RCC. Patrons will be directed to contact the Artist, who is solely responsible for sales and sales taxes. Sold art should remain on the wall until the end of the exhibit.
- Art should not be taken off the wall after the exhibit is hung except by prior arrangement with staff.

**NATURE OF EXHIBITIONS**

Since the Reston Community Center is a public facility utilized by all members of our community, the nature of daily activities requires some discretion in the type of work displayed. Work that is sexually explicit (work that is representational or realistic in depiction of human genitals will be considered sexually explicit by the RCC), or is graphically violent will not be considered appropriate to the space. If artwork that does not meet these guidelines is hung, the Reston Community Center reserves the right to remove the work and store it until the artist can be contacted. Center staff and artists work together to create an atmosphere that is sensitive to the multi-use nature of the facility.

**LIABILITY**

The Reston Community Center will not accept responsibility for damaged or stolen work. Staff will take all possible care to safeguard the exhibit. However, this is a public space and artists submit their work at their own risk. The Exhibitor's Release at the bottom of the page must be signed.
