On Sunday, April 15 at 8:00 p.m. come to the CenterStage for a two-thirds dose of the RSC comedy in *Wordplay—From Page to Stage with Reed Martin and Austin Tichenor*.

Tichenor and Martin are the managing partners of the Reduced Shakespeare Company. This year they thought they'd take Restonians behind the scenes for a glimpse of their glamorous lives as authors for the Reduced Shakespeare Company scripts and other literary efforts. In this evening of highly entertaining reading and commentary on the authorial side of their lives, they will share their work as writers of eleven works in four media. While you may think their whole lives have been occupied with ripping off rich source materials, you would be wrong. Separately they each have wives and lives—they will probably discuss these too.
